# **SGLGB** Milestones

## 2019 Pilot Test

1,029 barangays assessed 207 (20%) SGLGB passers

### 2021 Pilot Test

1,580 barangays assessed 549 (35%) SGLGB passers 2023 Roll Out

# SGLGB



The Seal of Good Local Governance for Barangay (SGLGB) is a performance assessment and recognition system that aims to give distinction to barangays with remarkable performance across various governance areas. It also intends to encourage barangays to continuously progress in delivering efficient, equitable and quality public services. It puts primacy to integrity and good performance as pillars of meaningful local autonomy and development.



### Purposes of the SGLGB Implementation and Its Results

- To assess performance of the barangays and generate information that are useful in policy program development, both at the local and international government levels
- To look into the feasibility of the new SGLGB implementation arrangement
- To serve as additional information in the regular review and evaluation of the Council of Good Local Governance (CGLG)

### Purposes of the SGLGB Implementation and Its Results

To serve as one of the bases in determining capacity development interventions, pursuant to DILG MC No. 2021-067, "Adoption of a Capacity Development (CAPDEV) Framework in the Planning, Design and Implementation for LGUs"

To endeavor "ONE AUDIT" for barangays, in response to the clamor of the DILG field offices and barangays to integrate to the SGLGB the various Barangay-Based Institutions (BBIs) functionality audits

- Section 5, Article II of the 1987 Constitution of the Republic of the Philippines
- Section 1, Executive Order No. 138 entitled: Full Devolution of Certain Functions of the Executive Branch to Local Governments, Creation of a Committee on Devolution, and for Other Purposes
  Section 3 (h) and 3 (m), and Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code (LGC) of 1991







Section 17 (b) (2) of Republic Act No. 7160



Section 5 (a) and 5 (b) of Rule II of the Implementing Rules and Regulations (IRR) of Republic Act No. 6975, otherwise known as the Department of the Interior and Local Government Act of 1990







- Section 2 of Rule V of the IRR of the SGLG Act of 2019 provides that DILG-BLGS shall oversee the SGLG assessment in the provinces, cities, and municipalities, while the DILG-NBOO shall oversee the assessment in the barangays
- Section 5 (c) of the SGLG Act of 2019 states the powers and functions of the Council of Good Local Governance (CGLG)

\*\* Total number of barangays per PSGC 2nd quarter of CY 2022; Barangay New Canaan, Sarangani was included in Q3 and merged barangays in Ormoc City in December 2022.



### Assessment Criteria





For the CY 2023 SGLGB, the principle <u>"3+1"</u> applies, where a barangay needs to pass ALL of the three (3) **Core Governance Areas** AND at least ONE of the **Essential Governance Areas**



# SGLGB SGLG



For CY 2023, the Council for Good Local Governance (CGLG) resolved that for a city or municipality to qualify in the SGLG, at least 50% of its component barangays must have participated in the SGLGB. This indicator serves as one of SGLG's tests of results acceptability in view of the oversight functions of a city or municipality over its component barangays.

The 2023 SGLGB results shall also serve as additional information in the regular review and evaluation of the CGLG pursuant to Rule IV, Section 2 (c) of the Implementing Rules and Regulations of Republic Act No. 11292 (hereinafter as SGLG Act of 2019), which states that the Council shall conduct an evaluation of the impact of the Act on the performance of the LGUs.

The implementation of the SGLGB is aligned with the intent of the SGLG Act to continuously raise the standards of performance of local governments, and in transforming local governments to becoming more accountable and responsive.


